That the board approve the proposed LCCP for the Bucks Lake planning unit, which LCCP describes how the proposed transaction conforms to and fulfills the requirements of the 2003 Settlement Agreement and Stipulation; and approve the proposed conservation covenant funding agreement between the Stewardship Council and Feather River Land Trust.

b. Hat Creek LCCP (Pit River Tribe Donated), Shasta County

That the board approve the proposed LCCP for the Hat Creek planning unit, which LCCP describes how the proposed transaction conforms to and fulfills the requirements of the 2003 Settlement Agreement and Stipulation; and approve the proposed conservation covenant funding agreement between the Stewardship Council and Shasta Land Trust.

c. Lake Almanor (Maidu Trail) LCCP (Maidu Summit Consortium Donated), Plumas County

That the board approve the proposed LCCP for the Lake Almanor (Maidu Trail) planning unit, which LCCP describes how the proposed transaction conforms to and fulfills the requirements of the 2003 Settlement Agreement and Stipulation; and approve the proposed conservation easement funding agreement between the Stewardship Council and the Feather River Land Trust.

d. Lake Almanor (Maidu Wetlands) LCCP (Maidu Summit Consortium Donated), Plumas County

That the board approve the proposed LCCP for the Lake Almanor (Maidu Wetlands) planning unit, which LCCP describes how the proposed transaction conforms to and fulfills the requirements of the 2003 Settlement Agreement and Stipulation; and approve the proposed conservation easement funding agreement between the Stewardship Council and the Feather River Land Trust.

- 3. Shasta County Fee Title Donee Recommendations
 - a. Hat Creek planning unit, Lake Britton Planning unit, Fall River Mills planning unit fee title donations to the Pit River Tribe

That the board select the Pit River Tribe to become the recipient of fee title to approximately 541 acres of watershed lands in the Hat Creek planning unit, 1,095 acres of watershed lands in the Lake Britton planning unit and 1,506 acres of watershed lands in the Fall River Mills planning unit, subject to compliance with all of the requirements of the Land Conservation Commitment, including the following terms:

- The Pit River Tribe provides a limited waiver of sovereign immunity to ensure that the conservation easement and other agreements executed pursuant to the Land Conservation Commitment are enforceable.
- The Pit River Tribe agrees not to petition the federal government to have the donated lands placed into federal trust.
- The board recommends that the Stewardship Council provide funding for future property tax obligations associated with this recommended donation.



b. Fall River Mills planning unit, Burney Gardens planning unit fee title donations to the Fall River Resource Conservation District

That the board select the Fall River Resource Conservation District to become the recipient of fee title to approximately 450 acres of watershed lands in the Fall River Mills planning unit and 1,612 acres of watershed lands in the Burney Gardens planning unit, subject to compliance with all of the requirements of the Land Conservation Commitment.
