LANDS IN SHASTA AND PLUMAS COUNTIES***

Roseville, Calif., January 9, 2019 – The Pacific Forest and Watershed Lands Stewardship Council, a land conservation and youth investment foundation, announces its next board of directors meeting will be held in Sacramento, CA on January 23, 2019. The agenda includes updates and important actions regarding the Land Conservation Program and other matters.

The Board may consider taking action on multiple items, including the following matters:

Board Adoption of Land Conservation and Conveyance Plans:

SHASTA COUNTY:

Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to the Pit River Tribe at the Hat Creek planning unit.

PLUMAS COUNTY:

Adoption of the proposed Land Conservation and Conveyance Plan for land to be retained by PG&E at the Bucks Lake planning unit.

Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to the Maidu Summit Consortium at the Lake Almanor (Maidu Trail) planning unit.

Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to the Maidu Summit Consortium at the Lake Almanor (Maidu Wetlands) planning unit.

Fee Title Donee Recommendations:

Board approval of the Pit River Tribe as prospective fee title donee for 541 acres within the Hat Creek planning unit, 1,506 acres within the Fall River Mills planning unit and 1,095 acres within the Lake Britton planning unit.

Board approval of the Fall River Resource Conservation District as the prospective fee title donee for 450 acres within the Hat Creek planning unit and 1,612 acres within Burney Gardens planning unit.
