PUBLIC ENCOURAGED TO ATTEND AND PROVIDE INPUT ON THE ADOPTION OF LAND CONSERVATION AND CONVEYANCE PLANS FOR LAND IN MADERA, BUTTE, PLUMAS, AND SHASTA COUNTIES

Roseville, Calif., April 18, 2018 – The Pacific Forest and Watershed Lands Stewardship Council, a land conservation and youth investment foundation, announces its next board of directors meeting will be held in Anderson, CA on May 2, 2018. The agenda includes updates and important actions regarding the Land Conservation Program and other matters.

The Board may consider taking action on the following matters:

Board Adoption of Land Conservation and Conveyance Plan:

MADERA COUNTY: Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to Madera County at the Manzanita Lake planning unit.

BUTTE COUNTY: Adoption of the proposed Land Conservation and Conveyance Plan for land to be retained by PG&E at the Butte Creek planning unit.

PLUMAS COUNTY: Adoption of the proposed Land Conservation and Conveyance Plan for land to be retained by PG&E at the Butt Valley planning unit.

PLUMAS COUNTY: Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to the Maidu Summit Consortium at the Humbug Valley Tasmam Kojom planning unit.

SHASTA COUNTY: Adoption of the proposed Land Conservation and Conveyance Plan for land to be donated to the University of California – Center for Forestry at the Pit River planning unit.

MENDOCINO COUNTY: Adoption of the revised proposed Land Conservation and Conveyance Plan for land to be donated to the Potter Valley Tribe at the Eel River (Trout Creek) planning unit.
